10. Life Member

At the face-to-face meeting, the President displayed the list of criteria that the Board use when considering a nomination for Life Membership of ALARA. The Board had decided to award Life Membership to Eileen Piggot-Irvine for her outstanding contributions to ALARA and the Action Learning / Action Research communities over the last 30+ years. The President read the supporting statement for the nomination of Eileen to the meeting, after which those present applauded.

11. Other Communications by Members

No comments were received from members at the Electronic part of the meeting.

The President opened the floor to a discussion on the future for ALARA.

At the face-to-face meeting, the President and Vice-President Australasia mentioned the intent to create a schedule of webinars over 2025, with various people approached to present those webinars. The meeting considered this an appropriate arrangement, and also suggested that approaches be made to universities to seek support.

The President re-emphasised the need for more support for the Board in being able to continue ALARA's activities. A question was asked about ALARA's purpose, to which the President referred to ALARA's vision and purpose statements on the website. ALARA's desire is to improve the world through the greater use of action learning and action research. ALARA aims to provide opportunities for members to network and communicate, such as the conference, to learn and improve their activities and to encourage others to use action learning and action research, and through that work, improve the world.

A suggestion was made for ALARA to regularly post items on social media, given the infrequency of current posting. The President highlighted the need for volunteers to support this work, to which one member offered assistance.

A suggestion was made for ALARA to propose to other associations that it participate in their conferences by offering a session / section / symposium presenting on action research. This idea has much merit, but it will require members to assist in the presentations.

The President thanked members for attending and closed the meeting.
