Why would you want to share your (action) research creatively?

- 1. The issue/practice that is the focus of your inquiry invites sharing the research in creative or alternative ways.
- 2. The methodology of an inquiry invites sharing the research in creative alternative ways. (for example, Hill and Rixon, 2021)
- The journal or conference where you are considering sharing has an agenda around creative presentation. (for example, ASRHE)
- 4. You are a challenging person, and you like to confront the status quo.

Action Research (Inquiry) context

What is action research?

- * Working with collaborators to solve a problem.
- * Cycles of inquiry

Performative Inquiry context

- 1. Narrative Turn stories used as data
- 2. Performative Turn
 - stories presented creatively
 - Haseman (2006) drew on OECD change in research (2002) to incorporate creativity. (The Creative Turn)

Poetry used in conference presentations

Heathcote Method (of Drama) that is useful for conference presentations

Dorothy Heathcote (1926-2011) developed a drama method drawn from the work of literary and theatre theorists and practitioners such as Victor Shklovsky and Bertolt Brecht.

A particular focus of Heathcote's work was using drama as a means of engaging students in reflective learning and inquiry. She called it 'Teacher in Role' (Johnson and O'Neill, 1984).

Heathcote Method (of Drama)

- 1. Think of a character who is linked to your research.
- 2. Costume
- 3. Invitation
- 'I am going to go away in a minute and when I return, I am going to pretend to be someone else. I am going to ask you to pretend to be someone else as well for example the downtrodden workers (for Foucault). Can you do this?
- 4. Change costume and become the other person.

Cabaret used in Conference presentations



- 1. I present cabarets
- Raelene Bruinsma, a fellow Australian and also PhD student, presented her work 'An Invitation To The Sacred Wedding Of Inanna and Dumuzi' in cabaret mode
- Kieran Fenby-Hulse in the U.K. attended a presentation of my cabaret at Brighton university and then began presenting his own style of cabarets around HR and leadership.
- First cabaret on reflective practice
- Doctoral cabaret on 'Doing a Doctorate'
- Cabaret on Research Supervision at International conference QPR
- Other cabarets in U.K. and Canada

Working with songs for a cabaret



- 1. Add music to something you have written.
- 2. Using songs and reframing them in the context of what you are presenting.
- 3. Changing the words of songs

Turning text into song



In my doctoral dissertation (Hill, 2002) I described my paradigm as

My ontological belief, in keeping with Kelly's (1955) theory of 'personal constructs is that people as 'personal scientists' construct their own version of reality.... Following from this, my epistemological belief in line with a practice tradition of knowledge (Schön, 1983) is that each person is constructing knowledge through selective Interaction with their own experiences of a range of issues..

The 7,024th Patient" project


an arts-informed, narrative study that resulted in an installation of poetry and photography that is 1,739 square feet in area and over 9 feet in height.


