Norwich University Vermont USA June 17-20 2018

Introduction

Ninety-one participants from eleven countries attended the Action Learning, Action Research and Participatory Action Research World Congress in June 2018. The World Congress was the first ALARA had held both in the USA and in partnership with Norwich University (at which an ALARA Chapter commenced the previous year). Many of the first-time ALARA event participants were surprised by, and expressed delight in, the openness and support provided by experienced participants.

The Congress participants were a mix of experienced AL / AR practitioners and graduating students from Norwich Master programs, who had undertaken action research projects as part of those programs.

A primary attraction for the Congress was the quality of keynote presenters. Many experienced practitioners commented on the presentations of these presenters, who were:

Promotion

Norwich University developed a promotional video for inclusion on the Congress and ALARA websites, which was one of the many contributions made by Norwich and its staff in making this event successful. ALARA sent emails to over 1,500 people known to be interested in Action Learning / Action Research, and arranged publication of the Congress on four conferencepromoting websites. Dr Pelletier promoted the Congress across Norwich University and associated organisations. Dr Tetteh also emailed a large number of universities in USA and Canada with Action Research affiliations.

Program Schedule

The Congress commenced with an opening event on the Sunday where William H. Clements, PhD. Vice President and Dean. College of Graduate and Continuing Studies, welcomed participants. The following morning, Dr Richard W. Schneider, Rear Admiral USCGR (Ret.), Norwich University's President, delivered his official welcome, after which the five keynote presenters engaged the participants.

Participants attended over thirty concurrent presentations, workshops and seminars, and five poster presentations over the three days of the Congress. A program for the Congress is available on the ALARA website.

Presenters were from most of the countries represented in the audience. Their topics were broad, within the five streams of:

- 1. Action Learning, Action Research Experiences of Individuals
- 2. Action Learning, Action Research Experiences of Professionals
- 3. Action Learning, Action Research for Communities' Developments
- 4. Action Learning, Action Research for Organizational Advancements
- 5. Action Learning, Action Research for Global Initiatives

The last session of the Congress was a Panel Debate, chaired by Dr Victor Friedman. This session was a great success and an excellent way to end the Congress. Dr Friedman invited the keynote presentations to sit at the front of the room on high stools to commence the discussion. He then invited the participants to swap with the keynote presenters on a rotating process by taking the chairs at the font of the room to continue the discussion.

Conduct

The program ran very smoothly, with minor problems on the evening of the welcome event due to the relocation of the venue (some university staff were unaware of the new location). The rooms for the concurrent sessions proved to be most appropriate for the size of the audience at each session.

The unexpected heat of the Monday made the sessions on that day difficult, but the weather cooled by the next day.

Not obvious from these lists or the financial summary below is the large number of important contributions made by Norwich University.

We thank these generous acts of support for the World Congress. We hope that all those who contributed were satisfied by the Congress's outcomes, communications and networking.

Financial

The Organizing Committee had expected a much larger audience, and the original budget reflected that expectation. Reduced registrations (discussed below) necessitated many changes to the schedule, including moving the welcome event and the concurrent sessions to smaller venues.

Through excellent management by the Congress administrator (Marcia Beaulieu), tremendous support by Dr Ro Pelletier and her team at Norwich, and distribution of some costs to other activities, the loss on the Congress was reduced to \$4,299 (USD). A summary of the income and expenditure is provided below and a more comprehensive report is available on request.

Feedback

ALARA executives led two reflection sessions at the end of the first two days, at which the participants made many comments (refer Appendix). The final Panel Debate, as mentioned above, was also an opportunity for participants to comment on the Congress, and many comments were highly supportive and complimentary. The desire expressed by many for increasing the awareness of action research in the community was encouraging.

Reflection on the Congress

The Congress was as the ALARA executive had hoped – high levels of communication, support and involvement by all participants in the sessions. The only disappointment was the relatively low number of participants.

Three people whose proposals were accepted withdrew when their universities declined to fund their attendance. At least one other person commented on the cost to attend and stay at the Congress location, while another commented on the distance between the closest available accommodation (at the time that person booked) and the University. It seems that the low cost of the dormitories (on-site) was not attractive enough for some of the potential participants.

Countering these views of getting to the venue was both the beauty of Vermont, Northfield and Norwich University and welcome expressed by so many during the Congress.

Lessons Gained

All aspects of the Congress, with the exception of the number of participants, worked well. The co-hosting of the Congress helped the relationship between Norwich and ALARA, although both organisations can gain much more from continuing their relationship.

The extensive promotion of the Congress did not translate into high numbers of registrations. Some non-registrations may have arisen from the competition caused by the ARNA Conference in San Diego two weeks later. ALARA attempted to gain ARNA's participation in the Congress, but that network chose to hold a separate event.

The location, cost of travel to that location, perceived cost of accommodation, and in some cases, lack of support by universities were possible contributing factors in lowering the number of registrations.

The Organizing Committee considered using a teleconferencing arrangement, but the cost of this arrangement was very prohibitive. The Committee could not utilize one option, sourced by Prof Pelletier, as the company had a conflicting event.

ALARA may need to investigate ways to conduct future events incorporating teleconferencing to expand the audience. Smaller events, with smaller costs, are also possible, and Norwich's ALARA Chapter is investigating holding such events in 2019.
